2. **Committee Involvement** -- Members are required to participate in at least two committee shifts to fulfill your volunteer duties.
An email will be sent to all CSA members with a link to the Volunteer Spot website. There you will be able to reserve volunteer dates and times that work for you.
Below are the various committees we offer -- please select one.

- Site Management Committee** - Set up and distribute produce (3pm-5pm), handle inquiries (5pm-7pm) or breakdown and clean-up (7pm- 9pm). Take this opportunity to get to know your fellow members and neighbors.
- Café Committee** – Help with prep work at Organic Soul Café.
- Newsletter/Media Committee**- Assist in the production of the bimonthly newsletter and CSA social media maintenance.

Please choose shift preferences and dates when you are emailed the information for Volunteer Spot. Contact us if you have difficulties.

3. **Produce Pick-ups and Absence** -- Pick-ups are Tuesdays 5pm– 8pm at Sixth Street Community Center. If you are unable to pick up your share during these hours, you may call or email us any time BEFORE 2pm on Tuesday and your share will be set aside for pick-up on another day. ***Please use this conservatively. Sixth Street CSA does not have adequate refrigeration for many shares to be held aside.*** (If you do not call your share will be donated to a soup kitchen or food bank). If you plan to be away for an extended period of time let us know if someone will be picking up in your place. Finally, please notify us if you decide to terminate or change your membership.
